Client Care: Provide low income transitional housing with a supportive aftercare program to ex-offenders who are working to transform their lives. During calendar year 2015, CRPIO served 66 clients with in-house services. Since organization, CRPIO has served 258 individuals. With the Wagee's Grant, we have served an additional 55 clients.

Client Housing: Currently CRPIO has 3 homes for men and 1 home for women in the Arapahoe County area of Aurora, CO. CRPIO's housing success rate is 85.38% for transitioning clients.
